OVERVIEW:

CANDIDATE REQUIREMENTS:

Each applicant must:

- be an Indiana resident;
- currently be enrolled in the senior class of an Indiana **public** high school;
- currently be classified as a special education student (as defined by 511 IAC 7);
- be applying to and accepted by an institution for post-secondary education for the 2010-2011 academic year; university, college, junior college or vocational education school.

1. If your special education planning district has more than one interested applicant, it is permissible to make copies of the official application materials. However, PLEASE MAKE CERTAIN THAT EACH CANDIDATE RECEIVES ALL OF THE FOLLOWING:
 - 1 copy of this instruction sheet,
 - 1 copy of the application and
 - 3 copies of the letter of recommendation.

2. All materials (application, 3 letters of recommendation and current transcript) should be mailed together in one packet.
 - It is the candidate's responsibility to insure that all materials arrive prior to the final deadline.
 - Incomplete applications with **missing materials or signatures** will not be reviewed.
